This license is issued by the Ministry of Trade and Industry and serves as government authorization for businesses to engage in importing specific products.

What are the import restrictions in Yemen?

Senders should determine import restrictions from Yemen authorities before posting: the containers can remain closed while their contents are checked. Any other alcohol including beer and spirits all volumes. Each parcel or each group of parcels dispatched simultaneously by a single sender to the same addressee requires a commercial invoice.
